

## **Tesla Rental Terms and Conditions**

**1. Agreement Overview:** By renting a Tesla vehicle from Sac Tesla Renters, you (the renter) agree to abide by the following terms and conditions. This agreement outlines the responsibilities of both parties during the rental period.

### **2. Rental Duration and Vehicle Use:**

- The rental period begins at the scheduled pickup time and ends at the scheduled return time.
- The Renter agrees to use the vehicle solely for personal or business use and will not use it for any illegal activities, including but not limited to transporting illegal substances or engaging in reckless driving.
- The vehicle must be returned in the same condition as when it was rented, including full fuel charge (or battery charge for electric vehicles).

### **3. Rental Fees and Payment:**

- The Renter agrees to pay the rental fee as outlined during the booking process, including any additional charges incurred during the rental period (e.g., mileage overages, late fees, damages).
- A valid credit card must be provided for payment. The Renter authorizes Sac Tesla Rentals to charge the provided card for the rental fees, any damages, late fees, or additional charges incurred during the rental period.

### **4. Cancellation and Refund Policy:**

- Cancellations made at least 24 hours in advance will receive a full refund.
- Cancellations made less than 24 hours before the scheduled rental period will result in a 100% charge of the total rental cost.
- No refunds will be provided if the Renter does not meet the required documentation or fails to pick up the vehicle.

### **5. Documentation and Insurance Requirements:**

- The Renter must provide a valid driver's license and proof of valid insurance before the rental can be completed.
- If the required documentation is not provided 24 hours before the time of vehicle pickup, the Renter will be charged 100% of the rental fee, and the reservation will be canceled.
- The Renter must ensure that the vehicle is adequately insured during the rental period. The Renter is responsible for any damages or accidents that occur during the rental if not covered by valid insurance.

## **6. Security Deposit:**

- A refundable security deposit may be required at the time of booking or vehicle pickup. This deposit will be refunded upon the safe return of the vehicle in the same condition, free of damages or excessive wear.

## **7. Mileage Limits:**

- The rental agreement includes a set number of miles per day (e.g., 100 miles per day). Excess mileage beyond this limit will incur an additional charge per mile as specified at the time of booking.
